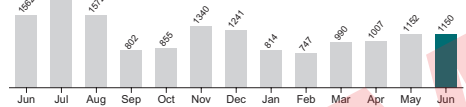

How to Read Your Newly Designed Washington Electric Cooperative Bill

Follow the numbers below as a guide to reading your new billing format.

- 1. Your bill amount and due date.
2. Account information, including account number, rate class, service and map location, meter number, and service dates.
3. Meter readings and kWh consumption total.
4. kWh usage history, which compares your monthly and daily electric service usage to the previous month and same time last year.
5. The account summary, which provides a detailed list of charges for the current billing period.
6. Important information and updates from Washington Electric Cooperative.
7. Your current address information on file. Please provide any updates or changes to this information in the designated space on the back of the bill.
8. Your account number and total due. To ensure proper credit, please detach and return the bottom portion with your payment.

Also, on the reverse side of this bill, you will find our office hours, payment options, disconnection/reconnection policies, and other important information about your bill.
